Fee Agreement and Contract For: Angie Sherwood, LCSW/Licensed Clinical Social Worker, Jessica Crocker, LMSW/Licensed Master's Social Worker, and Spring Baxter, LMSW/Licensed Master's Social Worker

1. FEE:The standard fee will be \$125.00 to \$150.00 per 45 to 60-minute individual, couples, or family session. Depending on insurance and other considerations, the initial fee for the first visit could be higher. Although health insurance may aid in payment, you are responsible for paying for psychological and counseling services and appointments with Angie Sherwood, LCSW, Jessica Crocker, LMSW, and Spring Baxter, LMSW at CARE Counseling for services not covered by insurance. We are contracted with most insurances and you will not be billed for insurance portions, but are responsible for your copayment and co-insurance amounts.

If you cancel or do not keep an appointment without giving twenty-four hours advance notice, you will be billed and required to pay \$50 for the time you have reserved. Insurance companies do not pay for cancelled appointments.

If you are ill and call in advance to cancel your appointment, and we are able to fill the appointment, there will be no charge.

If your insurance company requires you to get authorization from them before seeing a therapist and you do not do so, you agree to be responsible for full payment for services rendered and late fees if applicable.

2. PAYMENT ARRANGEMENT: All accounts are payable in full within 30 days after billing. Overdue

Accounts may be charged interest at the rate of 15% annually.

COLLECTIONS PROCEDURES: CARE Counseling Clinic, LLC reserves the right to collect any unpaid balance if the account is 30 days or more past due and there is no current payment arrangement agreement. Monies owed and unpaid to Angie Sherwood, LCSW, Jessica Crocker, LMSW, and Spring Baxter, LMSW may result in the use of a collection agency or legal action to secure payment, as authorized by state or federal law. The collections action will become a part of your credit record. Clients will be notified in writing before CARE Counseling Clinic, LLC takes action to collect.
- 4. LIMIT ON UNPAID BALANCE: Angie Sherwood, LCSW, Jessica Crocker, LMSW, and Spring Baxter, LMSW may terminate treatment and refer the client elsewhere for continued therapy if the unpaid balance exceeds \$300.00.
